

Terms and Conditions

1. This Authorization may be cancelled at any time upon notice by me/us. I/We acknowledge that, in order to revoke this Authorization, I/We must provide notice of revocation to The BERWICK ELECTRIC Commission, Town of Berwick, at least ten (10) calendar days before the due date of PAP. I/We may obtain a sample cancellation form or more information on my/our right to cancel a PAD Agreement at my/our financial institution or by visiting www.cdn.pay.ca.
2. I/We acknowledge that provision and delivery of this authorization to BERWICK ELECTRIC, Town of Berwick constitutes delivery by that bank/financial institution. Any delivery of this authorization to you constitutes delivery by me/us.
3. I/We acknowledge that this authorization is provided for the benefit of BERWICK ELECTRIC, Town of Berwick and any such bank/financial institution is provided in consideration of bank/financial institution agreeing to process debits against my account in accordance with the Rules of the Canadian Payments Association.
4. The BERWICK ELECTRIC Commission, Town of Berwick will provide, for fixed amount PADs, written notice of the amount to be debited and the due date(s) of debiting, at least ten (10) calendar days before the due date of the first PAD, and such notice shall be received every time there is a change in the amount or payment date(s).
5. I/We undertake to inform The BERWICK ELECTRIC Commission, Town of Berwick in writing, of any change in the account information provided in this authorization at least ten (10) calendar days prior to the next due date of the PAD.
6. I/We acknowledge that bank/financial institution is not required to verify that a PAD has been issued in accordance with the particulars of my/our authorization including, but not limited to, the amount.
7. I /We acknowledge that bank/financial institution is not required to verify that any purpose of payment for which the PAD is issued has been fulfilled by The BERWICK ELECTRIC Commission, Town of Berwick as a condition to honouring a PAD issued or caused to be issued by The BERWICK ELECTRIC Commission, Town of Berwick on my/our account.

8. Revocation of this authorization does not terminate any contract for goods or services that exists between me/us and The BERWICK ELECTRIC Commission, Town of Berwick. My/Our authorization applies only to the method of payment and does not otherwise have any bearing on the contract for goods or services exchanged.
9. You [or I/we, depending on the context] have certain recourse rights if any debit does not comply with this agreement. For example, you [I/we] have the right to receive reimbursement for any debit that is not authorized or is not consistent with this PAD Agreement.
